

# Blood Health National Oversight Group (BHNOG) Education Strategy Group (ESG) Terms of Reference (ToR)

## 1. Purpose

The Blood Health National Oversight Group (BHNOG) Education Strategy Group (ESG) has been established to implement the BHNOG Education Strategy 2021<sup>1</sup>. The strategy has been produced to ensure a structured and cohesive approach to transfusion education is taken in Wales which aligns with the objectives of the BHNOG/NHS Wales Blood Health Plan and its overarching work programme.

The ESG is responsible for developing the programme of work for delivering the strategy, including prioritisation. The ESG will collaborate with key groups and individuals to support and assist the delivery of transfusion education and embed transfusion principles and promote the safety culture associated with safe transfusion practice.

## 2. Aim

The aim of the ESG is to ensure a cohesive and standardised approach to transfusion education across Wales and working with BHNOG workstream leads, key healthcare professionals and subject matter experts to deliver effective and inclusive transfusion education programmes.

### 3. Governance

The ESG is accountable to BHNOG and follows recognised governance pathways defined in the BHNOG ToR<sup>2</sup>.

# 4. Chair

The ESG group will be chaired by a representative from within the core membership group and endorsed by BHNOG. A deputy Chair will also be recruited once group established
